

FEDERAL ACQUISITION REGULATION CLAUSES

If this order is placed under a Government prime contract or a federally-funded subcontract, then, in addition to the Calspan Systems Corporation General Purchase Order Terms and Conditions (QF-06-09(A)), the following clauses set forth in the Federal Acquisition Regulation (FAR), in effect on the date of this order, are incorporated herein by reference with the same force and effect as if given in full text. Where necessary to make the context of these clauses applicable to this order, the term “contractor” shall mean “seller,” the term “contract” shall mean “this order,” and the terms “Government,” “contracting officer” and equivalent phrases shall mean “buyer.” In the event of a conflict between the General Provisions and the FAR clauses (QF-06-09(B)) the FAR clauses shall prevail. Seller hereby agrees to flow down the applicable FAR clauses to its lower-tier contractors.
